Regular Meeting

1. Call to order.
2. Determination of quorum.
3. Public comment. In accordance with the Texas Attorney General's opinion, any public comment that is made on an item that is not on the published final agenda will only be heard by the Board of Commissioners. No formal action, discussion, deliberation, nor comment will be made by the Board of Commissioners.
4. District Chief's Report.
5. Review and approve minutes of the July 20, 2026 regular meeting.
6. Treasurer's Report, and review and take action on any proposed budget amendments and necessary account fund transfers (transfer funds to District's TexSTAR investment pool account).
7. Review, discuss and take action on proposed purchases/expenditures, including, but not limited to, hose/ladder testing.
8. Review, discuss and take action to approve and authorize payment of the District's bills and accounts.
9. Review, discuss and take any needed action District's property and liability insurance deductibles, coverage, and limits.
10. Review, discuss and take action of stand-by paramedic schedule and compensation policy.
11. Review, discuss and take any needed action regarding new Fannett fire station design/build project.

12. Review and take action to accept and approve the District's 2026 Certified Appraisal Roll and 2026 Tax Rate Calculation Worksheet.
13. Review, discuss and take action to approve the District's *proposed* 2026-27 budget by record vote.
14. Discuss and take action on the District's *proposed* 2026 property tax rate by record vote, schedule and announce public hearing concerning and meeting at which Board will vote to adopt the District's 2026 property tax rate, and authorize publication/posting of required notices concerning the 2026 property tax rate.
15. Discuss and take action on any other necessary matters relating to the District's FY 2026-27 budget and/or 2026 property tax rate.
16. Such other matters that may come before the Board.
17. Adjourn.
